All contents of the aforementioned publications are copyrighted. All material requires permission before being photocopied and/or reprinted. All requests to use material from *Arts & Economic Prosperity 5* must be made in writing. Please use the attached form.

Artwork

Illustrations and photographs appearing in *Arts & Economic Prosperity 5* are purchased by Americans for the Arts for one time use only. Permission to reproduce artwork must be granted by the artist (the artist will set payment conditions). If Americans for the Arts incurred no expense in obtaining the requested artwork, permission will generally be granted at no charge.

Miscellaneous

The Americans for the Arts logo is trademarked and permission is needed for reproduction. When permission to use or reproduce any portion of an *Arts & Economic Prosperity 5* study is granted, a credit line shall appear in a box on the front page on all reproductions that reads:

Types of Uses and Associated Costs

The sale of reproduced or use of material is strictly prohibited.

Nonprofit uses (such as in free or minimally charged conferences) will be permitted free of charge upon receipt of permission request form. All *Arts & Economic Prosperity 5* study partners fall into this category.

Educational institutions may use *Arts & Economic Prosperity 5* reports as study material. In courses for which students are charged tuition, there will be a charge of \$50 per course, per student.

Conferences, seminars, and workshops for which registration fees in excess of \$50 are charged will be charged a fee of \$50 per course, per use.

Publishers (books and magazines): Quotations of no more than two paragraphs will be permitted at no cost. For longer passages, a fee of \$50 per thousand words published will be charged. In-house newsletters are permitted to use material at no charge.

Instructions for requesting photocopying/reprint permission

1. Complete the reprint permission form.
2. Mail the form to Americans for the Arts, 1000 Vermont Avenue NW, 6th Floor, Washington, DC 20005, Attn: Nicole Goodman; scan and email the form to ngoodman@artsusa.org; or fax it to 202-371-0424.
3. If Americans for the Arts holds copyright for the requested material, the requestor will be notified of any charges; upon receipt of payment Americans for the Arts will send the requestor a letter granting permission for use. If copyright is not held by Americans for the Arts an effort will be made to reach the rights holder to gain permission on the behalf of the requestor. In some cases, the rights holder may wish to speak directly to the requestor.
